# Discounts

## How does it work?

- Members can access the portfolio of discounts through their member site.
- Due to HIPAA requirements, discounts are promoted differently for prospects, members who have not opted in and members who have opted in. Once opted in, additional discounts appear.
- Select Health & Wellness discounts do not require members to opt in (e.g., Fitbit® devices and PERS).
- Most discounts are powered by LifeMart who aggregates thousands of discounts on their co-branded microsite.

Most members opt in by following three easy steps.


Sign in to their member site **myuhcmedicare.com** and click the **Save big with member discounts** tile under **My plan resources**.

Upon first access, they will be prompted to opt in.

They will be directed to the discount's website.



Select D-SNP members, whose member site is **myuhc.com/communityplan**, are not required to opt in as they only have access to select Health & Wellness offers. They sign in to their member site, navigate to the **Health & Wellness** page and click the **Get member discounts** tile.

## How can you support your members?

- Help members know what to expect for 2025 and how to get the most out of their plan.
- Promote the discount categories – Health & Wellness, Travel, Electronics, Restaurants and Entertainment – rather than the specific offers.
- Encourage members to opt in, if necessary, so they can access the full portfolio of discounts.
