

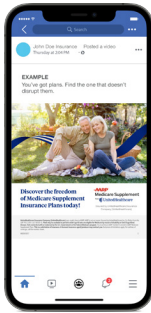


Path to Success: Your 2026 Marketing Material Roadmap

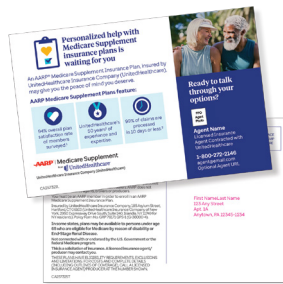
January

Jump start your year by downloading the seasonal social posts ahead of time so you're ready to keep your clients consistently engaged.

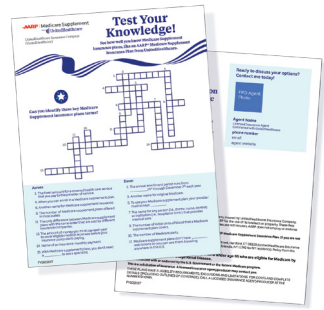
February

Let your clients know you're ready to provide personalized help with Medicare Supplement with this postcard that highlights the features that may give them peace of mind.

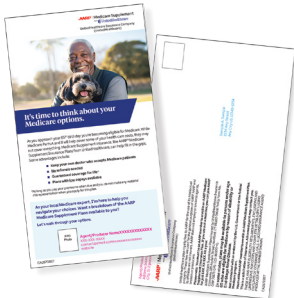
March

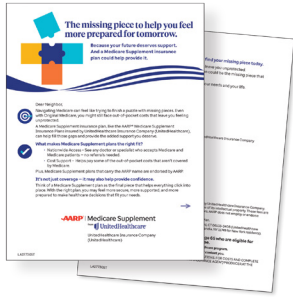


Med Supp I'm Your Local Agent Flyer

Promote yourself as a local agent while sharing some of the benefits prospective members could take advantage of with an AARP Medicare Supplement Insurance Plan.



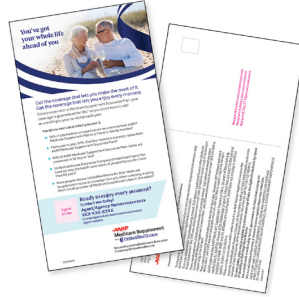
July

Mail this postcard to prospects who may be interested in coverage that doesn't slow them down. With guaranteed coverage for life,* enrollees will have one less thing to worry about.

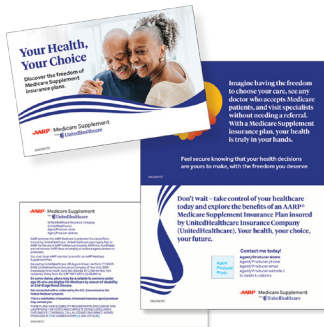
