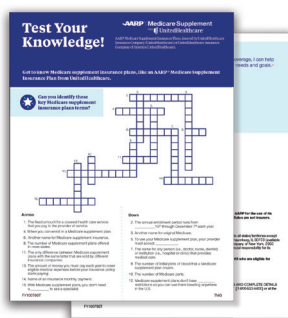
January

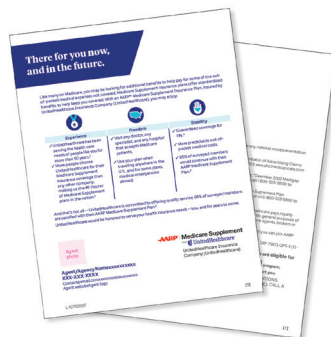

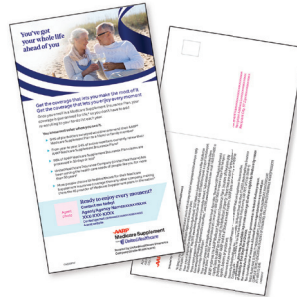
July
