Summary of D-SNP Enrollment Eligibility

Any dual-eligible consumer can enroll in a UHC D-SNP plan during AEP and MA-OEP

There are no changes to enrolling in D-SNP plans during AEP and MA-OEP. To enroll a consumer into the UHC Dual Complete FL-Y001 during AEP or MA-OEP, the consumer must enroll in the UHC Medicaid Managed Care Long Term Care (LTC) plan. Use the Jarvis Medicare and Medicaid Verification (MMV) tool linked on the D-SNP landing page to verify plan eligibility (see QR code above or navigate to Jarvis > Sales Tools > Medicare & Medicaid Eligibility Lookup).

Only certain dual-eligible consumers can enroll in a UHC plan using the Integrated Care SEP (see below)

- 1. If your client is Full Dual eligible (FBDE, QMB+, SLMB+), your client may be eligible for the monthly Integrated Care SEP and may enroll in any of our D-SNP plans except UHC Dual Complete FL-Y001. To enroll in UHC Dual Complete FL-Y001, your client must first enroll in the UHC Medicaid Managed Care LTC plan. Use the MMV tool linked above to validate your client's eligibility before you submit the application.
- Non-Full Duals (example: LIS and QMB only) are subject to the same SEP rules as MA.
- Special circumstance SEPs still apply to all D-SNP consumers; client must be Medicaid eligible. Refer to the Jarvis MMV tool for more information

To enroll in a UHC D-SNP plan using the Integrated Care SEP, consumers must be Medicaid eligible. To enroll in our FL-Y001 plan, they must enroll into the UHC Medicaid LTC plan first.

Medicaid Enrollment Period: Year Round

Does a consumer's D-SNP selection change their Medicaid plan? Yes, consumers who select a UHC D-SNP plan will automatically receive all of their Medicaid covered services through their UHC D-SNP plan. Note: LTC consumers must first call the state to change their LTC plan to the UHC LTC plan.

- In order for your clients' UHC Dual Complete FL-Y001 to be effective the first of the following month, clients must switch their LTC plan to the UHC LTC Plan by the 15th of the month.
- Full Dual eligible consumers with other LTC carriers will not be eligible to switch to the UHC LTC plan (UHC Dual Complete FL-Y001) using the Integrated Care Care SEP and are subject to Medicaid OEP rules to switch to the UHC LTC plan.
- · Medicaid LTC Open Enrollment begins October 1st and ends November 30th.

The healthy food and utilities benefit is a special supplemental benefit only available to chronically ill enrollees with a qualifying condition, such as diabetes, cardiovascular disorders, chronic heart failure, chronic high blood pressure and/or chronic high cholesterol, and who also meet all applicable plan coverage criteria. There may be other qualified chronic conditions not listed.
