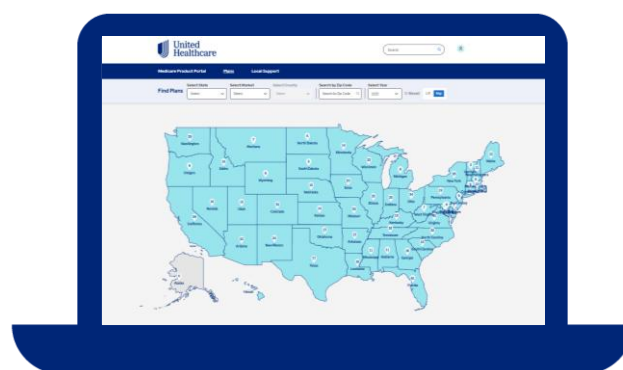
The Medicare Product Portal has been enhanced based on direct feedback from those who use it most. Highlights for 2026 plans include:

How it Supports You and Your Business

The Medicare Product Portal is your one-stop shop for UnitedHealthcare Medicare Advantage plan information. As an agent, it's your preview to the 2026 plans before benefits are released to consumers. As you prepare for AEP, use the portal to:

- Learn about plan specifics and compare plans in the same footprint to see how they differ
- Determine what benefits consumers will want to hear about first – apply filters to select plans with distinct features or benefit designs
- Analyze key metrics based on the selected footprint, even down to the county level
- Review the Dual Special Needs Plans for Medicaid eligibility levels to help you recognize which consumers are qualified to enroll

Important for 2026

- Sneak Peek will reflect a preview of plan benefits while the full plan details will be reflected once the benefits are finalized
- 2026 benefits and Sneak Peek are preliminary (pending CMS approval) and subject to final regulatory approval and may not be communicated to consumers or members prior to Oct. 1, 2025
- With the CMS removal of value-based insurance design (VBID), many MA plans offer Special Supplemental Benefits for the Chronically Ill (SSBCI) to members who meet CMS qualifying criteria. Learn about how members qualify for SSBCI in 2026 Certifications. In the Medicare Product Portal, these benefits will include text that reflects: 'for qualified members' so you'll be able to easily recognize this detail

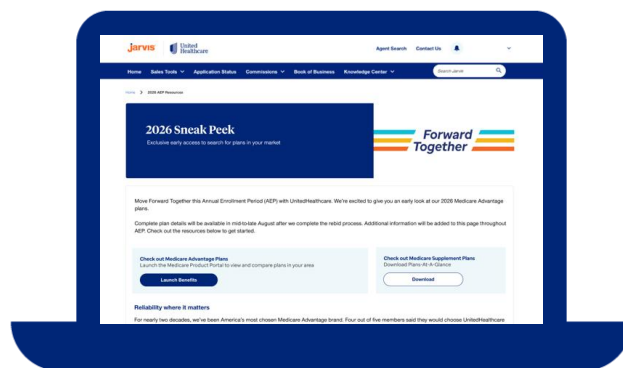
Best Practices and Pro Tips

- Save your searches to quickly access key plans – you can save up to two years of plan information
- Use 'Search' to find plans by plan name, plan ID or other key features
- Once final benefits are released, organize and export plan comparisons to PDF (enabled after rebid)
