



## **Important! Updates in Maryland for AARP Medicare Supplement Plans**

As of May 22, 2025, updates will be made in Maryland that impact AARP® Medicare Supplement Insurance Plans from UnitedHealthcare®.

### **Rating:**

UnitedHealthcare will transition to eligibility underwriting in Maryland for all new enrollments and current insured members changing plans outside of the Annual Birthday Enrollment, Guaranteed Issue, or Medicare Supplement Open Enrollment Periods. Applications will be required for all current insured members moving from one AARP Medicare Supplement Plan to another AARP Medicare Supplement Plan (with the exception of changing to plans A, K and L)<sup>1</sup>, even when changing plans during the Annual Birthday Enrollment Period.

**New applications will be required starting  
May 22, 2025.**

The new applications will be included in the Maryland Enrollment Kits that will be available beginning May 22, 2025 via the Sales Materials Portal, accessible via [Jarvis](#).

Please do not download or order large amounts of Enrollment Kits now. Any kits ordered prior to May 22, 2025, will be outdated and the applications will not be the correct version.

### **Changes to the Annual Birthday Enrollment Period:**

In order for eligible applicants to qualify for the Annual 31-day Birthday Enrollment period, applications must be received on their birthday or during the 30 days following. Proof of applicant's current Medicare Supplement plan must be provided at time of enrollment.<sup>3</sup>
